Mutual funds are required to distribute net gains from these sales to shareholders each year. Except for shares held in qualified tax-deferred accounts, such as individual retirement and 401(k) accounts, shareholders are required to pay taxes on distributions. These estimates are provided as of November 5, 2025 and are subject to change through the date of payment.
