The Balanced Fund pursues its objective by combining our Defensive Growth Strategy (70%) and our Flexible Fixed Income Strategy (30%). Our Defensive Growth Strategy can shift between money market instruments depending on our assessment of the risk-reward relationship of the stock market. Our Flexible Fixed Income Strategy adjusts the portfolio duration and credit quality based on our evaluation of the direction of interest rates and the credit risk environment.

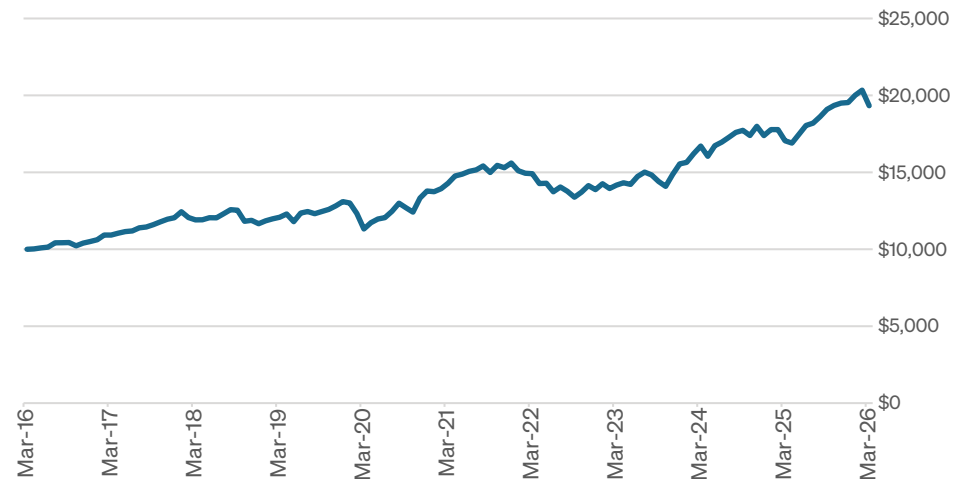
