The Muirfield Fund pursues its objective by utilizing a quantitative process to evaluate the risk-reward relationship of the stock market and invests in those areas believed to be demonstrating relative strength and value. The Fund may invest in various market capitalizations, specific industry sectors as well as international equities. As an unconstrained tactical strategy, the fund may also shift to money market instruments or fixed income securities when the risk-reward relationship of the stock market is deemed unfavorable.


